ALL PARTICIPANTS

RELEASE and WAIVER of LIABILITY, ASSUMPTION OF RISK, INDEMNITY AGREEMENT, and MEDICAL RELEASE

IN CONSIDERATION of being permitted to compete, officiate, observe, work for, volunteer on the track, have access to the track for filming purposes, or participate in any way in any ISA sanctioned event listed in the Events Schedule on www.scootercross.com, or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area required special authorization, credentials or permission to enter any area to which admission by the general public is restricted or prohibited, EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:

1. Acknowledge, agree and represent that he has or will immediately upon entering any such RESTRICTED AREA and will continuously thereafter inspect the RESTRICTED AREA which he enters and he further agrees and warrants that if at any time he is in or about RESTRICTED AREAS and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the RESTRICTED AREAS and or refuse to participate further in the EVENT(S).

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, equipment owners, drivers, pit crews, rescue personnel, any persons in the RESTRICTED AREA, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions or instructions to engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purpose herein referred to as "Releasees", FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of the FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT(S) WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT(S) whether caused the NEGLIGENCE OF THE RELEASEES or otherwise.

5. HEREBY acknowledges that the ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious bodily injury and or death and or property damage. Each of the UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk, Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in the EVENT(S) are conducted and that if any portion thereof is help invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The UNDERSIGNED AGREES to follow all Rules and Regulations described in the ISA Rule Book, or described by the Race Director at any time. UNDERSIGNED AGREES to use safety helmet, goggles, gloves, elbow and knee pads, appropriate shoes while participating in ISA events, that Pregnant persons should not participate in ISA Events, and that the UNDERSIGNED is not under the influence of alcohol or drugs before or during ISA Events, and that participation in ISA events should not be by persons unwilling or unable to take responsibility for their own actions

The UNDERSIGNED understands that high speeds, jumps and trick maneuvers are dangerous and could result in loss of control and other accidents, that when accelerating, climbing ramps, you will need to lean forward, under breaking conditions you will need to lean back, to keep wheel in contact with the ground.

The UNDERSIGNED warrants that he is either an adult in the state where he lives or that the person signing as his representative is his custodial parent or duly appointed legal guardian.

The UNDERSIGNED and his representative agree that, in the event that the undersigned requires medical or surgical treatment while under the supervision of ISA personnel in connection with any sponsored activity or trip, such ISA personnel may authorize medical treatment for the undersigned. The undersigned and his representative agree to pay for all medical, hospital, or other expenses that the undersigned may incur as a result of such treatment.

The UNDERSIGNED grants to the ISA and its employees, agents, and assign the right to photograph me and use my picture, silhouette, and other reproductions of my physical likeness as it may appear and any still camera photograph or videotape. The applicant also expressly grants to the ISA, its employees, agents and assigns the right to use any photograph, silhouette, or other reproduction of the applicant's physical likeness in connection with any television, theatrical or print exhibition, advertising or publicizing of ISA or any of its activities or programs. The applicant further gives ISA the right to reproduce in any manner whatsoever the applicant's voice or any instrumental/musical/sound effect produced by the applicant.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY AGREEMENT AND MEDICAL RELEASE AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
